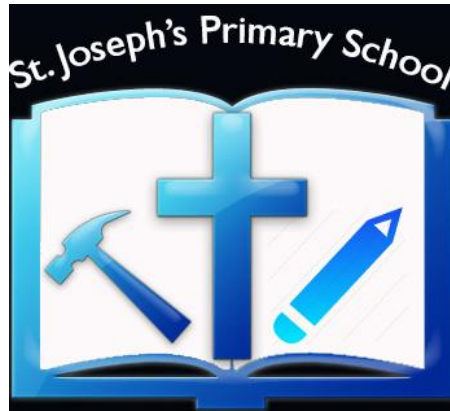

Rationale

In St. Joseph's Primary School, Meigh we believe that the Internet and other digital technologies are very powerful resources which can enhance and potentially transform learning and teaching when used effectively and appropriately. The Internet is an essential element of 21st century life for education, business and social interaction. This school provides pupils with opportunities to use the excellent resources on the Internet, along with developing the skills necessary to access, analyse and evaluate them in a safe, responsible manner.

E-Safety encompasses not only Internet technologies but also electronic communications such as mobile phones and wireless technology. It highlights the need to educate children and young people about the benefits, risks and responsibilities of using information technology. It provides safeguards and raises awareness to enable users to control their online experiences.

This policy is based on and complies with DENI Circular 2007/1 on Acceptable Use of the Internet and digital Technologies in Schools. The school's safe use of Internet and Digital Technology E-Safety Policy will operate in conjunction with other policies including those for Positive Behaviour, Anti-Bullying, Curriculum and Child Protection.

ICT Vision & Aims

St. Joseph's Primary School, Meigh fully acknowledges the role of ICT, digital and multimedia technology in enhancing learning & teaching and empowering learners. Using e-safety education to raise awareness for children and those who work with them about how to use digital technology safely and responsibly. Our ICT vision encompasses the following aims:

- E-safety education will be embedded into everyday school life.
- To provide opportunities to enable all staff and pupils to be confident and responsible users of digital technology.
- Across the curriculum at a level appropriate to their ability pupils will be empowered to use the internet and different technologies in a safe and positive way.
- ICT is embedded throughout the curriculum and as such supports the raising of standards in literacy and numeracy.
- ICT practice should build upon pupils' prior knowledge and provide opportunities for pupils to develop as independent and collaborative learners commensurate with their age and abilities.
- There is a need for balance between the development of ICT skills and the application of these skills to the curriculum.
- The ICT curriculum is well planned and co-ordinated across the areas of learning demonstrating suitable progression.
- ICT supports the thinking skills & personal capabilities framework within the Revised Curriculum and enables pupils to plan, do and review their work.
- To use ICT to develop an online community, sharing ideas and resources between pupils, staff, parents, Board of Governors, other schools and the wider community.

Methodology

Our e-safety curriculum is designed to help children keep themselves safe online by developing skills in identifying and avoiding risk, learning how to best protect themselves and their friends and knowing how to get support and report abuse if they do encounter difficulties.

Curriculum Leadership

The following section outlines the E-Safety roles and responsibilities of individuals and groups within the school.

Board of Governors

Governors are responsible for the approval of the E-Safety Policy. Governors will be provided with regular information about E-Safety incidents. The E-Safety Governor will:

- have regular meetings with the E-Safety Officer
- monitor of E-Safety incident logs
- report to relevant Governors meetings

Principal

- The Principal has a duty of care for ensuring the safety (including E-Safety) of members of the school community, though the day to day responsibility for E-Safety will be delegated to the E-Safety team.
- The Principal and members of the E-Safety Team should be aware of the procedures to be followed in the event of a serious E-Safety allegation being made against a member of staff. (*Appendix 1*)
- The Principal is responsible for ensuring that the E-Safety Team and other relevant staff receive suitable training to enable them to carry out their E-Safety roles and to train other colleagues, as relevant.

- The Senior Leadership Team will receive regular monitoring reports from the E-Safety Team.

E-Safety Co-ordinator (along with E-Safety team)

- Leads the E-Safety committee.
- Takes day to day responsibility for E-Safety issues and has a leading role in establishing and reviewing the school E-Safety policies / documents.
- Ensures that all staff are aware of the procedures that need to be followed in the event of an E-Safety incident taking place.
- Provides training and advice for staff.
- Liaises with the relevant body.
- Liaises with school technical staff.
- Receives reports of E-Safety incidents and creates a log of incidents to inform future E-Safety developments.
- Meets regularly with E-Safety Governor to discuss current issues, review incident logs and filtering changes.
- Attends relevant meeting of Governors.
- Reports regularly to Senior Leadership Team.

ICT Co-Ordinator

The Co-ordinator for ICT is responsible for ensuring:

- that the school meets required E-Safety technical requirements.
- that users may only access the networks and devices through a properly enforced password protection policy, in which passwords are regularly changed.
- filtering settings are differentiated to suit users' needs.
- any changes to filtering settings are recorded.
- that they keep up to date with E-Safety technical information in order to effectively carry out their E-Safety role and to inform and update others as relevant.
- that the use of the network, internet and Virtual Learning Environment is regularly monitored in order that any misuse / attempted misuse can be reported to the E-Safety Coordinator.

Staff

- All staff will sign an Acceptable Use Agreement on appointment. (*Appendix 3*)
- They have an up to date awareness of E-Safety matters and of the current school E-Safety policy and practices.
- They report any suspected misuse or problem to the E-Safety Coordinator.
- Staff must be aware of dangers to themselves in monitoring ICT use, for instance in viewing inappropriate images to investigate their source. Any allegation of inappropriate behaviour must be reported to senior management.
- All digital communications with students / pupils / parents / carers should be on a professional level and only carried out using official school systems
- Ensure E-Safety issues are embedded in all aspects of the curriculum and other activities

- Ensure pupils understand and follow the E-Safety and acceptable use policies
- Discuss the importance of research skills and the need to avoid plagiarism and uphold copyright regulations
- Monitor the use of digital technologies, mobile devices, cameras etc in lessons and other school activities (where allowed) and implement current policies with regard to these devices
- In lessons where internet use is pre-planned pupils should be guided to sites checked as suitable for their use and that processes are in place for dealing with any unsuitable material that is found in internet searches

Designated Child Protection Teacher

The designated child protection teacher should be trained in E-Safety issues and be aware of the potential for serious child protection / safeguarding issues to arise from:

- sharing of personal data
- access to illegal / inappropriate materials
- inappropriate on-line contact with adults / strangers
- potential or actual incidents of grooming
- cyber-bullying

Pupils

- All pupils will sign an Acceptable Use Policy and use the school systems in accordance with this. (*Appendix 2*)
- Staff reserve the right to enter any pupil's folder.
- Pupils must not use the Internet for unapproved purposes.
- Pupils should be discouraged from bringing mobile phones, hand-held gaming consoles with downloadable capabilities or mobile technology to school on the grounds that they:
 - are valuable and may be lost or stolen.
 - are capable of storing images that are inappropriate
 - do not have the internet filters appropriate for school.
- Will be expected to know and understand rules on the use of mobile devices and digital cameras. They should also know and understand policies on the taking / use of images and on cyber-bullying.
- Mobile phones are not permitted in school at any time.
- Have discussed the importance of research skills and the need to avoid plagiarism and uphold copyright regulations
- Need to understand the importance of reporting abuse, misuse or access to inappropriate materials and know how to do so
- Should understand the importance of adopting good E-Safety practice when using digital technologies out of school and realise that the school's E-Safety Policy covers their actions out of school, if related to their membership of the school

Parents

Parents / Carers play a crucial role in ensuring that their children understand the need to use the internet / mobile devices in an appropriate way. The school will take every opportunity to help parents understand these issues through parents' evenings, newsletters, letters, website and VLE.

Parents and carers will be encouraged to support the school in promoting good E-Safety practice and to follow guidelines on the appropriate use of:

- digital and video images taken at school events
- their children's personal devices in the school
- Parents will be asked to sign and return a consent form for pupil access to the Internet. *(Appendix 2)*
- Parents should be aware that the access to the Internet provided to staff and pupils in school has limiting security features.
- Parents should be aware that the use of the Internet in school is closely monitored by staff.
- Parents should be aware that there will be no use of the Internet without the supervision of staff and that this will be in full view of others, e.g. the classroom or the library
- Parents should, in co-operation with staff, make pupils aware of the rules and expectations within this document
- Parents should be aware that the use of ICT is complimentary to the teaching already done
- Parents should be aware that no photographs of pupils will be available online without parents giving their permission.
- Parents should discourage pupils from bringing mobile technology to school on the grounds that Internet access becomes very difficult to police.

Community Users

Community Users who access school systems as part of the wider school provision will be expected to sign a Volunteer User Agreement before being provided with access to the school systems. *(Appendix 3)*

E-Safety Education

Education - Pupils

Pupils need to learn safety rules in a way that does not frighten them and which gives them confidence to know what to do in certain situations. E-Safety should be a focus in all areas of the curriculum.

- A planned E-Safety curriculum should be provided as part of PDMU and ICT lessons. It should be regularly revisited.
- Key E-Safety messages should be reinforced as part of a planned programme of assemblies and pastoral activities.
- Pupils should be taught in all lessons to be critically aware of the materials they access online and be guided to validate the accuracy of information.
- Pupils should be taught to acknowledge the source of information used and to respect copyright when using material accessed on the internet.
- Pupils need to understand that certain rules will change and develop as they get older.
- Pupils need to learn how to apply strategies that will help them to avoid certain risks.
- Pupils need to understand that E-Safety rules given to them must be followed.

Cross Curricular Skills

E-safety will be taught and reinforced through all areas of the curriculum.

Promoting Thinking Skills and Personal Capabilities

At the core of our vision for E-safety is that we are aiming to encourage pupils to think critically and apply this to real life situations. Our methodology also aims to promote collaborative learning. The teaching of Thinking Skills and Personal Capabilities is inextricably intertwined to the goals of the E-safety policy.

Education - Parents/Carers

Parents play an essential role in the education of their children and in the monitoring / regulation of the children's on-line behaviours.

The school will therefore seek to provide information and awareness to parents and carers through:

- letters, newsletters, web site, VLE
- parents / Carers sessions
- E-Safety themed week
- reference to the relevant web sites / publications

Education & Training - Staff/Volunteers

It is essential that all staff receive E-Safety training and understand their responsibilities, as outlined in this policy. Training will be offered as follows:

- E-Safety training for staff will be regularly updated and reinforced.
- An audit of the E-Safety training needs of all staff will be carried out annually.
- all new staff should receive E-Safety training as part of their induction programme, ensuring that they fully understand the school E-Safety policy and Acceptable Use Agreements.
- this E-Safety policy and its updates will be presented to and discussed by staff.
- the E-Safety Team will provide advice / guidance / training to individuals as required.

Training – Governors

Governors should take part in E-Safety training sessions, with particular importance for those who are members of any sub group involved in technology, health and safety or child protection. This may be offered in a number of ways:

- Attendance at training provided by the Local Authority.
- Participation in school training / information sessions for staff or parents (this may include attendance at assemblies / lessons).

Introducing the Safe Use of Internet and Digital Technologies to:

Pupils

- Safe use of Internet rules will be posted in all networked rooms and discussed with the pupils at the start of each year.
- Pupils will be informed that network and Internet use will be monitored.
- Instruction in responsible and safe use should precede Internet access.

Staff

- All staff will be given the School E-Safety Policy and its importance explained.

Parents

- Parents' attention will be drawn to the School E-Safety policy.

Technical – infrastructure / equipment, filtering and monitoring

- The school will work with C2k, and the Internet Service Provider to ensure that the school meets recommended technical requirements.
- Servers must be securely located and physical access restricted.
- Appropriate security measures are in place to protect the servers.
- There will be regular reviews of the safety and security of school technical systems.
- The ICT coordinators are responsible for ensuring that software licences purchased by the school match the number of software installations.
- Internet access is filtered for all users.
- Senior staff will ensure that regular checks are made to ensure that the filtering methods selected are appropriate, effective and reasonable.
- If staff or pupils discover an unsuitable site, it must be reported to the E-Safety Team.
- All users will be provided with a username and password. Users are responsible for the security of their user name and password.
- All users are made aware that the school may check their computer files and may monitor the Internet sites visited.
- Guests requiring temporary access will be given a guest username and password and will have to sign an Acceptable Use Agreement before gaining access to the network.
- School devices that may be used out of school should only be used by a designated user
- Staff should be aware that downloading executable files can corrupt the system.

Managing Emerging Technologies

Emerging communications technologies offer the potential to develop new teaching and learning tools, including mobile communications, wide Internet access and multimedia. A risk assessment needs to be undertaken on each new technology and effective practice in classroom use developed.

- Emerging technologies will be examined for educational benefit and a risk assessment will be carried out before use in school is allowed.
- The school has a set of clear expectations and responsibilities for all users
- The school adheres to the Data Protection Act principles
- All users are provided with and accept the Acceptable Use Agreement
- All network systems are secure and access for users is differentiated
- Where possible these devices will be covered by the school's normal filtering systems, while being used on the premises.
- All users will use their username and password and keep this safe
- Training is undertaken for all staff
- Regular audits and monitoring of usage will take place to ensure compliance
- Any device loss, theft, change of ownership of the device will be reported.

Making and Storing Digital and Video Images

When using digital images, staff should inform and educate pupils about the risks associated with the taking, use, sharing, publication and distribution of images. In particular they should recognise the risks attached to publishing their own images on the internet e.g. on social networking sites.

- Staff and volunteers are allowed to take digital / video images to support educational aims, but must follow school policies concerning the sharing, distribution and publication of those images.
- Staff members should where possible use school equipment. They may use personal digital cameras on field trips but any images should be appropriately transferred back to a centralised area in the staff public folder and deleted from their personal camera.
- Care should be taken when taking digital/video images that pupils are appropriately dressed and are not participating in activities that might bring the individuals or the school into disrepute.
- All images will be deleted when they are no longer required.

Digital and Video Images of pupils on school websites

Including images of pupils on the school's website can be motivating for the pupils involved and provides good opportunities to celebrate and promote the work of the school.

- Parental consent will be requested to cover use of such photographs throughout the school year before using images of pupils on the website or elsewhere.
- Where possible, group photos will be used rather than full-face photos of individual children.
- Names and images will be kept separate.

Protecting Professional Identity

When communicating with parents and members of the wider community staff should only use school systems, e.g. school e-mail, school website and phone in school office. All communications should be professional in nature.

Social Media

School staff should ensure that:

- No reference should be made in social media to pupils, parents / carers or school staff.
- They do not engage in online discussion on personal matters relating to members of the school community.
- Personal opinions should not be attributed to St. Joseph's Primary School or local authority.
- They do **not** correspond with pupils through social networking sites or add them as 'friends'.
- Security settings on personal social media profiles are regularly checked to minimise risk of loss of personal information.

Social Media – Responsible Use

Within school we have an e-safety curriculum which ensures that;

- Children are aware of the legal ages for social networking sites.
- Children are aware of appropriate online behavior.
- Children are equipped to be responsible users.
- Children are aware that all online activity can be monitored.
- Children have an understanding of privacy settings and how important it is to use them.
- Children understand what to do if they are worried about anything they have seen online.

Mobile Devices

Pupils are not permitted to bring mobile phones/internet capable/video or camera enabled devices to school.

Staff may use camera phones when necessary, however all images should be deleted before leaving the school building at the end of the day.

When using mobile devices such as i-pads pupils and staff must adhere to the guidelines stated in Acceptable Use Policies. Digital and video images taken on mobile devices must be deleted as soon as they have been used.

Respecting Children's Rights and Equality of Opportunity

St. Joseph's Primary School aims to empower children through ICT and enhance their protection. It will contribute to the realisation of the rights of the child to participation, education, and protection from abuse, violence and exploitation in the digital world by addressing the following articles from a Summary of the UN Convention on the Rights of the Child;

- Article 3 – best interests of the child.
- Article 12 – respect for the views of the child.
- Article 13 – freedom of expression.
- Article 17 – access to information from the media.
- Article 36 – other forms of exploitation.

St. Joseph's Primary School's ICT facilities are available for use by all pupils and staff. All children are given access to ICT regardless of gender, race, physical or sensory disability.

E-Safety and SEN

Children with Special Educational Needs (SEN) can use the digital technologies in educational, creative, empowering and fun ways. However, they may be particularly vulnerable to e-safety risks. In collaboration with the SENCO class teachers will develop strategies for safe use of digital technologies for children with SEN.

Professional Development

The school is committed to cater for teachers' professional development needs within the area of e-safety. These include the following key elements:

- A clear and user-friendly E-safety policy and curriculum overview.
- An appropriate and varied range of resources.
- The support and encouragement of the e-safety team.
- Ongoing training and professional development as required.

The Monitoring and Evaluation of the E-Safety Policy

The school will monitor the impact of this policy using:

- logs of reported incidents
- pupil and staff questionnaires

Review Cycle of Policy

The E-safety policy will be reviewed and updated annually. This process will involve an e-safety group consultation. A copy of the policy will be available in the school office on request.

User Actions – Unsuitable / Inappropriate activities

The school believes that the activities referred to in the following section would be inappropriate in a school context and that users, as defined below, should not engage in these activities in school or outside school when using school equipment or systems. The school policy restricts usage as follows:

Handling E-Safety Complaints (Appendix 1)

This guidance is intended for use when staff need to manage incidents that involve the use of online services. It encourages a safe and secure approach to the management of the incident. Incidents might involve illegal or inappropriate activities.

- Parents, teachers and pupils should know how to submit a complaint.
- A range of sanctions will be required when rules are breached, linked to the school's disciplinary policy.

Illegal Incidents

- If there is any other suspected illegal activity, report to the E-Safety Team.
- If the school identifies a suspect computer (containing for instance indecent images or offences concerning child protection), it should **not** be used or viewed. Schools should isolate any devices concerned and take advice from local police.
- **In some circumstances such interference may also constitute a criminal offence. Potential child protection or illegal issues must be referred to the school Designated Child Protection Coordinator or E-Safety Team.**

After a major or minor incident a comprehensive debriefing should occur to review school policy and procedures, to make and monitor any necessary changes and to maximise what can be learnt.

- Complaints of Internet misuse will be dealt with by the E-Safety Team.
- Any complaint about staff misuse must be referred to the E-Safety Co-Ordinator.
- Complaints of a child protection nature must be dealt with in accordance with school child protection procedures.
- Pupils and parents will be informed of the complaints procedure.

School Actions & Sanctions - Pupils

It is important that any incidents are dealt with as soon as possible in a proportionate manner, and that members of the school community are aware that incidents have been dealt with. It is intended that incidents of misuse will be dealt with through normal behaviour / disciplinary procedures.

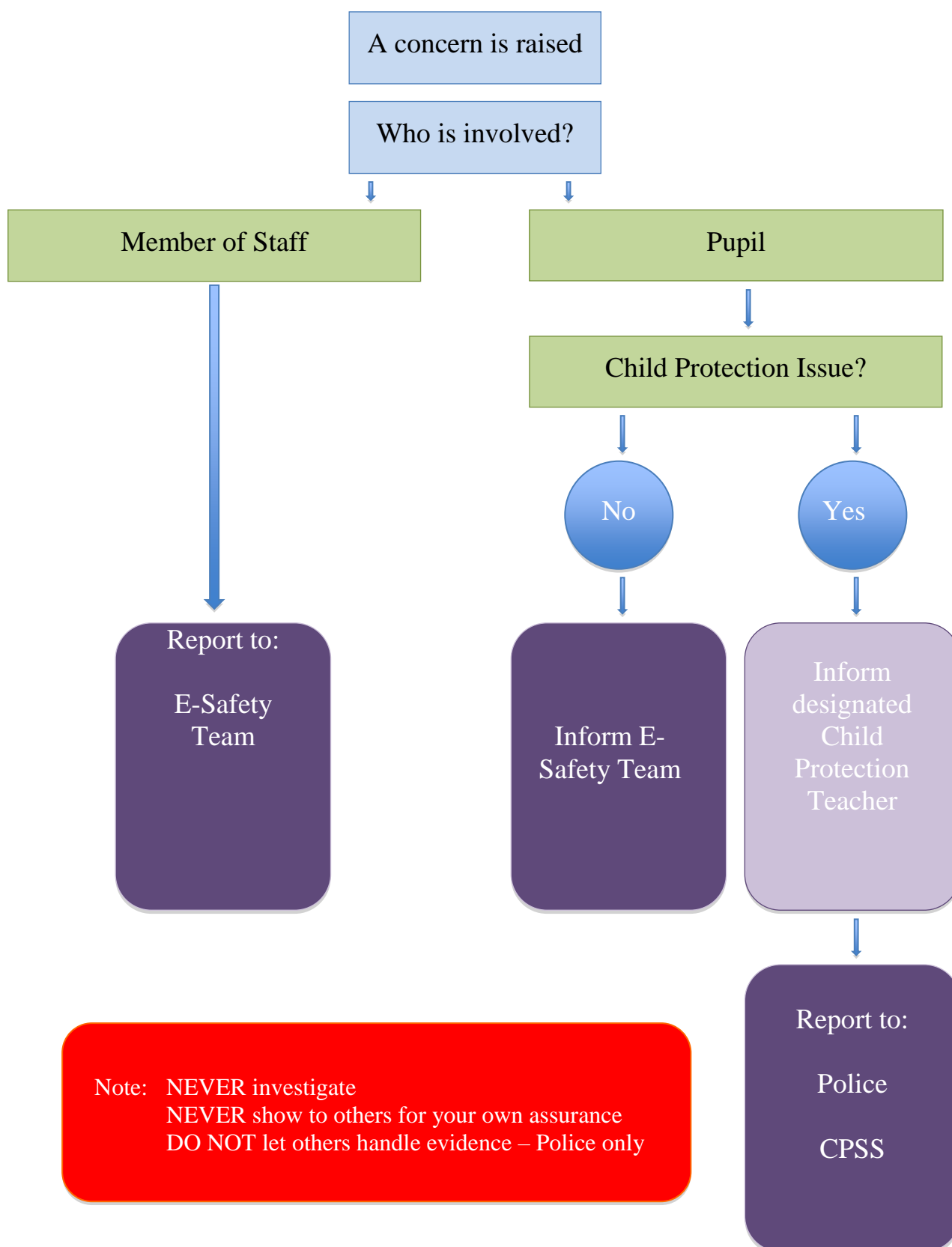
Addendum

- Network administrators reserve the right to review files and communications to maintain system integrity and ensure that the users are using the system responsibly – they will respect the right to privacy whenever possible
- The school will take all reasonable precautions to ensure that users access only appropriate material. However, due to the international scale and linked nature of Internet content, it is not possible to guarantee that unsuitable material will never appear on a school computer. Neither the school nor C2k can accept liability for the material accessed, or any consequences of Internet access.
- The school will audit ICT provision to establish if the E-Safety policy is adequate and that its implementation is effective.

Responding to incidents of misuse

Illegal Incidents

If there is any suspicion that the web site(s) concerned may contain child abuse images, or if there is any other suspected illegal activity, refer to the right hand side of the Flowchart (below and appendix) for responding to online safety incidents and report immediately to the police.



Other Incidents

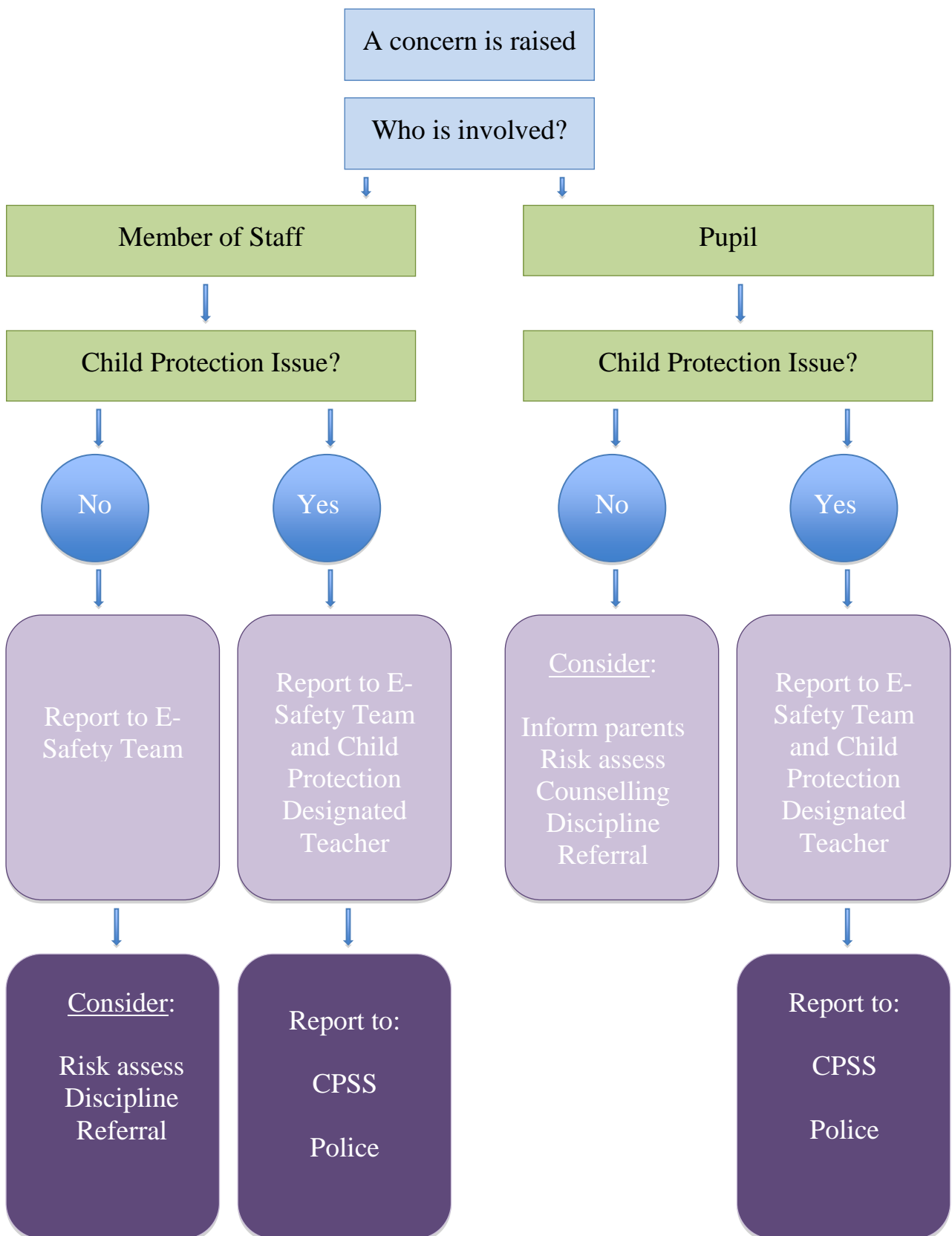
It is hoped that all members of the school community will be responsible users of digital technologies, who understand and follow school policy. However, there may be times when infringements of the policy could take place, through careless or irresponsible or, very rarely, through deliberate misuse.

In the event of suspicion, all steps in this procedure should be followed:

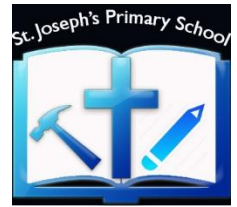
- Have more than one senior member of staff involved in this process. This is vital to protect individuals if accusations are subsequently reported.
- Conduct the procedure using a designated computer that will not be used by young people and if necessary can be taken off site by the police should the need arise. Use the same computer for the duration of the procedure.
- It is important to ensure that the relevant staff should have appropriate internet access to conduct the procedure, but also that the sites and content visited are closely monitored and recorded (to provide further protection).
- Record the url of any site containing the alleged misuse and describe the nature of the content causing concern. It may also be necessary to record and store screenshots of the content on the machine being used for investigation. These may be printed, signed and attached to the form (except in the case of images of child sexual abuse – see below)
- Once this has been completed and fully investigated the group will need to judge whether this concern has substance or not. If it does then appropriate action will be required and could include the following:
 - Internal response or discipline procedures
 - Involvement by Local Authority or national / local organisation (as relevant).
 - Police involvement and/or action
- **If content being reviewed includes images of Child abuse then the monitoring should be halted and referred to the Police immediately. Other instances to report to the police would include:**
 - incidents of 'grooming' behaviour
 - the sending of obscene materials to a child
 - adult material which potentially breaches the Obscene Publications Act
 - criminally racist material
 - other criminal conduct, activity or materials
- **Isolate the computer in question as best you can. Any change to its state may hinder a later police investigation.**

It is important that all of the above steps are taken as they will provide an evidence trail for the *school* and possibly the police and demonstrate that visits to these sites were carried out for child protection purposes. The completed form should be retained by the group for evidence and reference purposes.

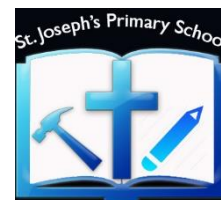

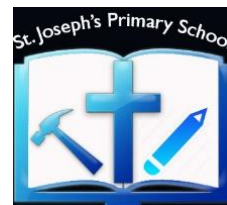

Read about what they are and maybe you could even download a poster and stick it next to your computer so **everyone** knows how to stay safe online!



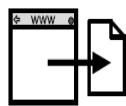
SAFE

Meeting someone you have only been in touch with online can be dangerous. Only do so with your parents' or carers' permission and even then only when they can be present.



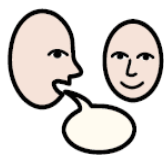
ACCEPTING
